**THE OBJECTIVE OF THE CONFERENCE**, cosponsored by the Institut D'Économie Industrielle ([IDEI](#), Toulouse) and the Centre for Economic Policy Research ([CEPR](#), London), is to discuss recent academic contributions to our understanding of the economics of the Software and Internet Industries, whether theoretical, econometric, experimental or policy oriented.

**TOPICS TO BE COVERED** include (this list is suggestive and not limitative; all contributions to our understanding of these industries and their consequences are welcome):

- ◆ The industrial organization of the Software and Internet Industries (competition and regulation, contractual relationships, strategies of firms, demand).
- ◆ Macroeconomic consequences (growth, employment) of the Software and Internet Industries.
- ◆ E-commerce, including jurisdictional issues/taxation and competitive strategies.
- ◆ The Internet and the financial sector.
- ◆ New technologies of information and communication and the organization of firms.
- ◆ Intellectual property policy for the Software and Internet Industries.
- ◆ Software platforms as two-sided markets.

This conference is part of the program “Competition Policy in International Markets”, organized by the CEPR.
